



Booster Meeting Minutes
Virtual ZOOM Meeting | Monday, 06.29.20 | 6pm

The meeting was called to order by head band director, Donnie Christian at 6:06pm with 25 members in attendance via ZOOM. Please know ZOOM is the current meeting format due to the COVID-19 lockdown. The meeting was not audio or video recorded and there was no formal agenda, but the main item for discussion was the voting on 2020-2021 executive committee officers.

Mr. Christian spoke of new guidelines which were discussed during a district head director's meeting. It was noted that there will be no college instructors (football, cheer, band etc.) on any campus during COVID-19 to help reduce the spread of the virus. Also, it was discussed rather or not the band should be competitive by canceling any marching band or ensemble competitions. It was also, discussed that maybe the spring and fall band competitions could be flipped (concert and marching band) but everything is still in the planning and review stages. As for summer band and rehearsals, everything is still on schedule but will follow CDC guidelines with social distancing, the wearing of masks and sanitizing hands and surfaces.

Joe Skelton gave a quick review of the firework building and stated that they have taken all safety percussions such as using masks and wiping down surfaces, he also, expressed the need for additional adult volunteers and that sales have been slow but steady.

Financial Report:
